







MORE CLIENT SATISFACTION

The Adelaïde Group, parent company of Verlingue, Génération and Cocoon, announced the Group's performance and achievements for the previous year on April 4th. The Group achieved an aggregate turnover of €400 million in 2023, recording 18% growth compared with 2022. Verlingue reported a total turnover of €285 million in 2023, a 19% increase, supported mainly by a strong organic growth but also targeted acquisitions, with around 35% of Verlingue's business generated outside France. Génération, which specialises in managing Health Insurance and pension contracts, is consolidating its growth with an 18% fully organic increase in comparison with 2022, achieving a turnover of €102 million in 2023. And with a turnover of 13 million euros, Cocoon, which specialises in the distribution of health and personal protection insurance for individuals, aims to become a recognised stakeholder in the digital and ethical distribution of supplementary Health insurance solutions.

Insurance intermediation in Switzerland: new regulation from January, 1st 2024

To operate on an untied basis, all insurance intermediaries must now acquire and prove the skills and knowledge required for their activity by means of a recognised diploma. They also have to be supervised by FINMA (Swiss Financial Market Supervisory Authority).
